

Internationalization of HE: content...

...A PROCESS OF INTEGRATING THE INTERNATIONAL, INTERCULTURAL OR GLOBAL DIMENSION INTO THE PURPOSE, FUNCTIONS OR MISSION OF HE (KNIGHT, 2004).

INTERNATIONALIZATION ABROAD IS UNDERSTOOD AS ALL KINDS OF EDUCATION OUTSIDE BORDERS, I.E. THE MOBILITY OF STUDENTS AND STAFF OF EDUCATIONAL INSTITUTIONS AS WELL AS CROSS-BORDER COOPERATION (CROSS BORDER EDUCATION).

HOME INTERNATIONALIZATION IS MORE CURRICULUM -TEACHING AND LEARNING- OUTCOMES ORIENTED, FOCUSING ON ACTIVITIES THAT DEVELOP INTERNATIONAL AND/OR GLOBAL UNDERSTANDING AND INTERCULTURAL SKILLS FOR ALL STUDENTS IN THE HOME LEARNING ENVIRONMENT (EUROPEAN PARLIAMENT, 2015).



LAW 3549/2007: BY DECISION OF THE HEIS... IT IS POSSIBLE TO UNDERTAKE A DOCTORAL THESIS AND ORGANISE ALL OR
PART OF AN UNDERGRADUATE OR POSTGRADUATE COURSE OF STUDY IN A FOREIGN LANGUAGE... (ARTICLE 17)

- LAW 4692/2020: HEIS MAY ORGANISE FIRST CYCLE PROGRAMMES OF STUDY IN A FOREIGN LANGUAGE... (ARTICLE 82)
- EUROPEAN FUNDING (2021-2027): THE ACTION "SUPPORT FOR INTERNATIONALIZATION OF HIGHER EDUCATION" INCLUDES THE DESIGN, DEVELOPMENT AND IMPLEMENTATION OF FOREIGN LANGUAGE CURRICULA, THE PRODUCTION OF THE NECESSARY EDUCATIONAL MATERIAL, WITH EMPHASIS ON OPEN ACCESS DIGITAL EDUCATIONAL MATERIAL, THE PRODUCTION OF MATERIAL FOR THE PROMOTION OF INSTITUTIONS AND THEIR FOREIGN LANGUAGE PROGRAMMES, THE REMOVAL OF BARRIERS TO ATTRACTING STUDENTS FROM OTHER COUNTRIES, THE SUPPORT OF THESE STUDENTS TO SETTLE AND STAY IN OUR COUNTRY IN A SAFE AND ORGANIZED WAY, AS WELL AS THE SUPPORT OF THE DEVELOPMENT OF FOREIGN LANGUAGE PROGRAMMES IN OUR COUNTRY.

The International Hellenic University

- LAW 3391/2005: THE ESTABLISHMENT OF IHU IS A FIRST SYSTEMATIC OPENING OF THE COUNTRY OUTSIDE THE BORDERS WITH THE RESPONSIBILITY OF THE STATE, ADDRESSED TO THE YOUNG PEOPLE OF THE COUNTRIES OF OUR CLOSE AND WIDER GEOGRAPHICAL NEIGHBOURHOOD (BALKANS, BLACK SEA COUNTRIES, AEGEAN COUNTRIES AND COUNTRIES OF THE SOUTH-EASTERN MEDITERRANEAN).
- LAW 4610/2019: ONE OF THE BASIC CARACTERISTICS OF IHU WILL BE MODERN CURRICULA THAT WILL TREAT INTERNATIONALLY RENOWNED FIELDS OF SCIENCE AND TECHNOLOGY... WITH INTERNATIONAL CHARACTER.

- LAW 4009/2011: ADDITIONAL FUNDING BEYOND THAT REFERRED TO IN THE PREVIOUS PARAGRAPH SHALL BE ALLOCATED TO THE INSTITUTIONS ON THE BASIS OF THE QUALITY AND PERFORMANCE INDICATORS OF EACH INSTITUTION. THE QUALITY AND PERFORMANCE INDICATORS SHALL BE, IN PARTICULAR, THE FOLLOWING:... INTERNATIONALISATION, SUCH AS THE NUMBER OF FOREIGN STUDENTS, THE NUMBER OF STUDENTS ATTRACTED TO THE INSTITUTION THROUGH EUROPEAN EDUCATIONAL PROGRAMMES AND THE NUMBER OF COOPERATION AGREEMENTS WITH OTHER HIGHER EDUCATION INSTITUTIONS IN GREECE OR ABROAD.

 - ... THE FOUR-YEAR STRATEGIC PLAN OF EACH UNIVERSITY INCLUDES AT LEAST THE STRATEGY IN THE FOLLOWING AREAS...INTERNATIONALISATION OF THE INSTITUTION (ARTICLE 15)
 - HIGHER EDUCATION INSTITUTIONS (HEIS) OF THE COUNTRY MAY JOINTLY ESTABLISH A NON-PROFIT COMPANY FOR
 THE PURPOSE OF PROMOTING, SUPPORTING AND STRENGTHENING THEIR INTERNATIONALISATION AND
 PROMOTING THEIR WORK EXTERNALLY (ARTICLE 293).

A synopsis: The current state of play in Greece - International Students

- DESPITE A HIGHER NUMBER OF APPLICATIONS FROM INTERNATIONAL STUDENTS, ONLY 3% OF FIRST-TIME ENTRANTS INTO BACHELOR'S PROGRAMMES AS OPPOSED TO OECD AVERAGES OF 8% AT BACHELOR'S LEVEL
- AT THE SAME TIME... 5% OF NATIONAL TERTIARY STUDENTS ARE ENROLLED ABROAD, MORE THAN THE OECD AVERAGE OF 2% (OECD, 2019)
- THE SHARE OF INTERNATIONAL STUDENTS REMAINED STABLE BETWEEN 2011 AND 2021.

Recent Developments

Colleges in Greece

there are 35 colleges operating in greege

30 colleges are operating as a franchise of UK universities

there are NO OFFIGIAL DATA about the share of students

colleges focus on NATIONAL AND FOREIGN STUDENTS

- LAW 4093/2012: COLLEGES ARE PROVIDERS OF NON-FORMAL POST-SECONDARY EDUCATION AND TRAINING SERVICES WHICH PROVIDE STUDIES EXCLUSIVELY ON THE BASIS OF VALIDATION, FRANCHISING AGREEMENTS WITH HIGHER EDUCATION INSTITUTIONS ABROAD, RECOGNISED BY THE COMPETENT AUTHORITIES IN THE COUNTRY WHERE THEY ARE ESTABLISHED, LEADING TO A FIRST BACHELOR'S DEGREE OF AT LEAST THREE YEARS' DURATION OF STUDY AND ATTENDANCE, OR A MASTER'S DEGREE. [...] ARE NOT EQUIVALENT TO THE TITLES AWARDED UNDER THE GREEK FORMAL EDUCATION SYSTEM
- LAW 4653/2020: (PROFESSIONAL) RECOGNITION OF QUALIFICATIONS AWARDED BY COLLEGES IN GREECE
- LAW 5094/2023: ESTABLISHMENT OF NON-PROFIT UNIVERSITIES IN GREECE

The debate in Greece

1990-2010

- Private universities:

- MORE THAN 40,000 GREEKS ARE STUDYING ABROAD (5% OF GREEK
 STUDENTS). THIS BRAIN DRAIN HAS SERIOUS SOCIAL AND ECONOMIC
 CONSEQUENCES BOTH AT THE LEVEL OF INDIVIDUALS AND FAMILIES AND
 FROM THE POINT OF VIEW OF GENERAL INTEREST (LOSS OF CAPITAL AND
 POTENTIAL ECONOMIC TRANSACTIONS, LOSS OF NEW SCIENTIFIC
 POTENTIAL) (LAW, 5094/2024).
- PROVISION IS MADE FOR THE POSSIBILITY FOR HIGHER EDUCATION INSTITUTIONS TO ESTABLISH A NATIONAL OFFICIAL REPRESENTATIVE BODY UNDER THE NAME "STUDY IN GREECE", IN THE FORM OF A NON-PROFIT CIVIL COMPANY, WITH THE AIM OF PROMOTING, SUPPORTING AND STRENGTHENING THEIR INTERNATIONALISATION, AS WELL AS PROMOTING THEIR WORK ABROAD (LAW, 5094/2024).

- STRENGTHENING RELATIONS WITH THE EU INTERNATIONAL ORGANISATIONS
- LINKING EDUCATION WITH THE LABOUR MARKET
- ENSURING AND IMPROVING THE QUALITY OF STUDIES
- DEVELOPING A COMMUNICATION AND SUPPORT FRAMEWORK FOR GRADUATES OF THE MEMBER COLLEGES AND STRENGTHENING OUR COMMON INTERESTS
- ATTRACTING FOREIGN STUDENTS, WITH A VIEW TO FURTHER PROMOTING AND CONSOLIDATING GREECE AS A CULTURAL, INTELLECTUAL AND INTERNATIONAL EDUCATIONAL CENTRE

UK universities in Greece

- IN 2020–21, 510,835 STUDENTS WERE STUDYING FOR AWARDS FROM 162 UK PROVIDERS IN 228 COUNTRIES AND TERRITORIES THROUGH TRANSNATIONAL EDUCATION (TNE). WITH 21,530 STUDENTS, GREECE IS THE TOP HOST COUNTRY FOR UK TNE STUDENTS IN THE EU AND SEVENTH GLOBALLY.
- UK TNE PROGRAMMES HAVE BEEN OFFERED IN GREECE SINCE THE EARLY 1990S BY LOCAL PARTNERS WHO OPERATE AS PRIVATE COLLEGES.

 THE MAJORITY OF UK TNE PROVISION IN GREECE HAPPENS THROUGH FRANCHISE AND VALIDATION ARRANGEMENTS. MORE THAN 90% OF UK TNE STUDENTS ARE OF GREEK NATIONALITY, WITH A SMALL NUMBER OF STUDENTS COMING MAINLY FROM BALKAN COUNTRIES.
- THE NATIONAL EDUCATION STRATEGY ENCOURAGES THE INTERNATIONALISATION OF THE GREEK HIGHER EDUCATION SECTOR AND RECENT REFORMS HAVE GIVEN GREEK UNIVERSITIES POWERS AND INCENTIVE TO PURSUE COLLABORATIONS WITH FOREIGN UNIVERSITIES. SPECIFICALLY, THESE INCLUDE THE FREEDOM TO DEVELOP UNDERGRADUATE AND POSTGRADUATE PROGRAMMES IN ENGLISH; SPECIFIC FUNDS AND FINANCIAL INCENTIVES FOR UNIVERSITIES TO MEET AND EXCEED THEIR INTERNATIONALISATION TARGETS; AND INTERVENTIONS TO SUPPORT UNIVERSITIES TO ATTRACT INTERNATIONAL STUDENTS (UNIVERSITIES UK INTERNATIONAL, 2021).

Concluding remarks...

- GREECE DID NOT PURSUE, IN THE PAST, A SYSTEMATIC COHERENT POLICY OF ATTRACTING STUDENTS, ESPECIALLY FROM ITS NEIGHBOURING COUNTRIES THE BALKANS, NORTH AFRICA, THE MIDDLE EAST- AND/OR AN INTERNATIONALISATION STRATEGY,
- IN THE LAST FIVE YEARS AN INTENTION TO DEVELOPING INTERNATIATIONALISATION (?) POLICIES HAS BECOME EVIDENT,
- THE GREEK STATE SEEMS TO HAVE OUTSOURCED TO THE UNIVERSITY THE RESPONSIBILITY FOR THE DEVELOPMENT AND IMPLEMENTATION OF INTERNATIONALISATION (?) POLICIES

AND AN OXYMORON: INTERNATIONALISATION IS ALMOST EXCLUSIVELY ABOUT ATTRACTING (INTER-)NATIONAL STUDENTS!
